Participate in consultation with the Minister in relation to any proposed section 37(5) regulations declaring an area to be a prescribed area for the purposes of **DCCS** section 37 of the Liquor Licensing Act CEO, Approval of an application for the extension of a trading area where the council section relevant area is under the control of the council DCCS, 69(3)(e) MPC Lodge a complaint under section 106(1) regarding unduly offensive, CEO. section council 106(2)(b) annoying, disturbing or inconvenient activity, noise or behaviour relating to **DCCS** licensed premises
