

STATEMENT OF REPRESENTATION – CATEGORY 3

Pursuant to Section 38 of the *Development Act, 1993*

Representations

Representations must be made in writing, and a Statement of Representation form must be completed and supplied. The Statement of Representation form requires persons making a representation to state their name and address, and describe the reasons for their representation and how the issues would be overcome.

The written statement is more likely to be effective if it refers to the provisions of Renmark Paringa Council Development Plan. This can be accessed via the Renmark Paringa Council website, www.renmarkparinga.sa.gov.au/developmentplan.

Copies of representations are forwarded to the applicant, and the applicant is given the opportunity to respond in writing to the representation. A report will then be prepared for the consideration of the Riverland Regional Assessment Panel, as the delegate of Council.

It is not necessary to attend a Riverland Regional Assessment Panel meeting, but you may choose to do so to make a verbal presentation of your concerns. Please note that the time for making a verbal presentation will be limited to approximately 5 minutes.

For Category 3 development, Council must allow a representor to appear to make their representations. The applicant is also allowed to appear in order to respond to any representations.

Council advises representors with notice of its decision. In the case of a Category 3 development, representors have the right to lodge an appeal against the decision with the Environmental Resources and Development Court.

Under the *Development Act 1993*, any person may, in accordance with the Development Regulations 2008, make a representation in writing to the relevant authority in relation to the granting or refusal of consent of a Category 3 development application.
